January/February 2022 Reorganization

When will this reorganization take place?

The projection process for the upcoming reorganization has already begun. Members should be aware of the following dates:

lanuar:	Administrators will be underlying School Class Summarios over this period of time. Kind experten		
January	Administrators will be updating School Class Summaries over this period of time. Kindergarten		
13-18	classes will be generated centrally and shared with schools. The In School Staffing Committee		
	should be consulted during this time and prior to the submission of the school's new School		
	Class Summaries to the Superintendent's Office.		
January	Administrators will advise teachers if there will be a change in their assignment by January 28.		
28	Excess Teachers will receive their (Temporary) Excess to School letter by 1pm.		
January	Excess teachers will receive placement instructions and a list of vacancies from their Principal by		
31	2pm.		
February	Excess teachers must complete the online selection form, review it with their Principal and		
1	submit it by 2pm.		
February	The Administrative Placement Meeting will be held to place excessed teachers. The current		
4	principal will inform teachers of their new placement and receiving principals will contact		
	teachers to welcome them to their new school.		
February	Schools losing a teacher may start their reorganized timetable on Thursday, February 10.

February	Administratively placed teachers will arrive in their new schools on Thursday, February 10. They		
10 & 11	will have February 10 and 11 to meet with students, new staff, grade teams and set up their		
	classrooms.		
February	All reorganized classes are to be in place as of Monday, February 14.

How will this reorganization be different from other reorganizations?

As with the September 2021 reorganization process, all teachers excessed from their school during this reorganization process will only be temporarily excessed from their home school. They will be returned to their home school's organization for the purposes of the G32 process.

Members who were temporarily excessed during the September 2021 reorganization may have the option of returning to their home school or remaining at their temporary location for the remainder of 2022. Choice should be provided where it is possible. If members find themselves in this situation, they are strongly encouraged to reach out to their PETL Vice-President liaison for help understanding the process and their options.

A member may volunteer to be temporarily excess to the school in place of another member. This must be approved by administration and the Superintendent.

Is there anything I need to do in preparation for this reorganization?

The Board shared the Interim Seniority list via email on December 15, 2021. Should members have concerns, they have until January 12, 2022 to query their position on the list. The finalized seniority list will be used for both the January/February Reorganization and the upcoming G32 process.

Should the In-School Staffing Advisory Committee (ISSAC) be meeting about the reorganization?

Yes – The ISSAC should meet sometime between January 13-18, 2022 to consult about reorganization that may need to occur. The ISSAC should be particularly mindful of class sizes being proposed as a part of the reorganization as well as whether or not any members will be temporarily excessed from the school. Concerns and questions about your school's reorganization should be shared with your PETL Vice-President liaison.

Will any teachers be 'protected' from re-assignment during this reorganization process?

Only 1.0 FTE teachers will be temporarily excessed. Therefore, members who work part-time at one or two locations should not be excessed. Additionally, members who are assigned to contained Special Education and Section 23 classes will not be excessed. No other teachers will be "protected" unless they are the only teacher holding a specific and required qualification.
