- All the steps necessary to propose amendments to the constitution were fulfilled; these include:
  - submitted to the Executive (at least 30 days prior to the AGM)
  - approved by the Executive

  - The PETL Constitution will be amended if 60% of the members present at the AGM vote in favour of the proposed amendment

- (d) Chair the Occupational Health and Safety Committee and serve as the Occupational Health and Safety Teacher Advisor.
- (e) To attend and provide to the President and Executive, written reports upon the proceedings of school board committees to which the Local is invited to send representation.
- (f) To be the Local's contact with members seeking access to LTD and pregnancy/parental benefits and to assist members with LTD, pregnancy/parental leave and retirement processes.
- (g) To forward to the president information from members experiencing personal difficulties not related to LTD or pregnancy/parental leave.
- (h) To forward to the Chair of the Collective Bargaining Committee, member issues related to clauses in the Collective Agreement.
- (i) Other duties as assigned by the President or Executive including assisting, as requested, with member issues of a personal nature. (Effective June 29, 2023)
