- 5. WELCOME & PRESIDENT'S REMARKS: Gail Bannister-Clarke, President
  - Thanked everyone for standing up for a quality education model here in Peel and fighting against the hybrid model
  - Thanked Karen Brown and Michelle Leonard for joining us today
  - Hybrid is still being used when there is a classroom closure due to classroom closures due to COVID in Grade 6, 7 and 8 classes
  - Discussed the importance of our PETL Strategic plan and conveyed how we are always revisiting and revamping this plan on a year-to-year basis

## **6. PROVINCIAL REMARKS:** Karen Brown, ETFO President

- Karen Brown shared that she is a former resident of Peel and has some close connections to our district
- Thanks all members for coming out to the GMM and thank President Gail Bannister-Clarke for all the wonderful work we are doing here in Peel and congratulated our President for putting her name forward in the past Federal Election campaign
- Provided an update regarding the Charter Challenge and ETFO is still waiting for decision and we are hoping for a decision before the end of the year
- Congratulated us our win on pushing back on the fractured Hybrid Model
- The vast majority of our members are vaccinated and we are hopeful that vaccines will be approved for children between the ages of 5-11 in the coming months
- Vaccines are not the only solution, we are still fighting for enhanced ventilation, a robust a testing and contact tracing, smaller class sizes, enhanced PPE and government advisory table that includes local public health experts
- We need to rally to vote in a new government when provincial elections take place next year

#### 7. COLLECTIVE BARGAINING: Michelle Leonard, ETFO Collective Bargaining Staff Liaison

- Acknowledged that it has been a stressful start to the school year for all of our members with COVID protocols and a delayed re-org
- The message at our recent PETL Town Hall meeting was that teachers are simply burned out
- An update was provided on a grievance that was filed for PETL: planning time payback for teachers in virtual schools
- There was a lack of hiring for virtual schools and teachers were asked to switch to asynchronous learning at the end of the learning day; this resulted in planning time payback issues for our members
- An arbitrator decided in ETFO favour regarding this issue in the Hamilton School Board which helps set a precedent for Peel

#### **10.** EXECUTIVE OFFICER PORTFOLIO REPORTS:

10.1 Organizing - Vickita Bhatt & Felipe Pareja, Vice-Presidents

#### WHAT IS ORGANIZING?

Organizing is about building powerful connections with others — especially those with whom we share a common cause or struggle. In a union context, it's about building *true* union power by connecting, one-to-one, constantly, with every worker in the workplace in an effort to foster unbreakable solidarity. It also involves looking outwards, and building connections with like-minded community organizations and community members. It's about recognizing the reality that the only way to win the schools and communities we all deserve is to come together and to fight together.

#### LOCAL COMMUNICATIONS AS A MEANS TO ORGANIZING

As a local, we employ a number of communication channels to assist with information sharing, capacity-building, and organizing. These include, but are not limited to:

- our three social media channels (Twitter, Facebook, Instagram);
- regular all-member emails (including our bi-weekly eNews);
- our Steward's Toolkit emails;
- our Frequently Asked Questions documents;
- our Message from the President emails; and
- our local website.

#### **GOALS FOR WORKPLACE ORGANIZING**

This year, Stewards, Alternates, and members will work together to build *Site Solidarity Structures* that break down their work site into small groups (or squads), each with a Squad Leader whose role it will be to communicate one-to-one with the members of their squad on union-related business. As we continue to engage in collective actions to build power (e.g. statements, letter/email actions, social media actions, marches/rallies), these structures will allow *all of us* to know whether or not we're reaching the supermajority participation necessary to demonstrate true union power. All members in the work site will play a critical role in the development of their *Site Solidarity Structure*.

#### 10.2 Collective Bargaining - Jessica Cooper & Mandi Hardy, Vice-Presidents

- November 3<sup>rd</sup> is the bargaining survey deadline
- We have a newly elected Collective Bargaining Committee
- This committee will be communicating with the broader membership through things like an all-member survey and town hall meetings
- There is a letter of intent on page 109 of our CA; this letter of intent was written to see how members could access Family Responsibility
- There was an agreement that conversations would continue with the board so that we can perhaps expand on the definition of what defines a Family Responsibility day
- Explained how grievances are settled or resolved
- ETFO is always brought onboard and are filed by ETFO itself
- There are specific and somewhat short timelines that must be followed when pursuing a
  grievance so if members are aware of a breach of the collective agreement it is important
  that they reach out to their PETL liaison as soon as possible so that they can begin the
  process of resolving or escalating the issue

- Vice President Hardy eluded to the fact that we have a lot on our plates
- It's important to recognize that despite how busy we might be, continuing our equity work is extremely important to continue with all the equity work we do in our classrooms everyday
- Members are asked to review any memos that are sent out by the Local or the Board which will help move members along on their equity journey
- It's important to embed all of this learning into our day-to-day practices
- There are vacancies on the DARE/PEAC committee and those applications will be open until November 12, 2021

## 10.4 Occupational Health & Safety - Chris Hoffman, Vice-President

- MERV 13 filters continue to be used in school HVAC systems
- All HVAC systems are scheduled to get UVGI purification systems by Dec 31<sup>st</sup>, 2021
- All classrooms without mechanical ventilation should have a HEPA filter
- All Kindergarten classrooms should have a HEPA filter, and K classrooms without mech ventilation should have two HEPA filters
- As of today, 202 covid notifications, 186 cohorts dismissed
- In the 4<sup>th</sup> wave, we are not seeing an increase as we did in the 2<sup>nd</sup> and 3<sup>rd</sup> waves
- The Local continues to track all covid notifications to proactively identify trends
- It is important that all safety protocols are being followed in schools
- The Local continues to advocate for improved safety and to raise concerns about gaps in Covid-related measures
- The Reopening Plans have been updated 4 times so far
- Members are reminded that as per Ministry guidance, as much distance as possible should always be promoted between students, between students and staff, and between staff members.
- Members are encouraged to use the Workplace Incident Reporting tool to report any incidents covered under Bill 157
- Report any concerns or concerns to your admin. Contact your VP Liaison if concerns are not addressed after speaking to admin
- The H&S Bulletin Board should be in an accessible location for all workers, and should not be in a room used as the isolation room
- Designated Workers and alternate workers are still needed in some school locations. PETL Members are encouraged to apply. See the H&S Newsletter that was in the eNews last Friday, and under the H&S tab on the ETFOPeel Website for the link to apply for one of those positions.
