2. PRESIDENT'S REPORT & REMARKS - Nadia Goode

- 2.1. 2025-2026 Meeting Dates
 - A final version of important dates will be emailed to the full Executive and PETL Office Staff before school starts
- 2.2. Annual Meeting Debrief
 - Protests impacted members' sense of safety, candidates visited the suite, issues of equity arose, the election of our next executive was held and resulted in an executive with no one who has lived experience as a Black member being elected
 - There was disruption and disrespect on the floor despite Robert's Rules
 of Order enforcing decorum; it also suppressed members' voices, and
 resulted in harm during in the meeting
 - Further protests, actions, acts of solidarity resulted from the third day's events
 - The lack of response from ETFO Leadership and the General Secretary is unacceptable
 - For ETFO to release a statement in solidarity with Air Canada Flight

- Attendants but not address what happened at Annual Meeting is also intolerable
- Peel with the second largest delegation, a purposefully diverse and representative delegation, has fought the anti-Blackness and racism that persists in spaces, including our Annual Meeting; the Peel delegation had discussions about the events that transpired and these continue, and will lead to action items for our Local
- 2.3. ETFO Leadership
 - Congratulations to Manjit Deol on her election to the ETFO Executive
- 2.4. The End of Policing (Group Project)
 - Alex Vitale The End of Policing
 - In Peel there was a lot of work done to remove Police resource officers from our schools and Bill 33 looks to undo those efforts
 - In response to Bill 33, returning to a police presence in schools, as an Executive we can do the work together to read and discuss at each of our Executive meetings
 - Andrea Vasquez with the Police Free Schools organization may also be able to join us at a future meeting

- 3.4. Operating Procedures High Level Overview Nadia Goode
 - Meals
 - Meals at Committee Meetings in person are in the proposed budget to be expensed at \$25 maximum per person
 - Committee meals will not be provided for virtual meetings, and they will not be reimbursed
 - Communal meals are a great way to be cognizant of the budget
 - Committees meeting on the same night can also consider combining the meal
 - Please complete the Meeting/Function Sheet for all meetings and events; if your regular committee meetings require the same set up, you can list all the dates and details on one sheet and hand it in at the start of the year
 - Page 16, Section 12 outlines Executive PD Funds
 - If you borrow something from the PETL Office make sure it comes back
 - Mileage
 - When the event is a full day event at one location, mileage is <u>not</u> reimbursed
 - When a Chair or Committee Member is coming from a work location to a meeting after school, mileage is reimbursed from school to PETL Office to home
 - When an Executive, Chair or Committee Member, is going to an event to volunteer and "work" an event on behalf of the local

- mileage cannot be claimed
- When an Executive, Chair or Committee Member is attending an event and volunteering to "work" an event the member cannot claim mileage as they are attending sessions and receiving the same benefits as participants
- A Committee Chair/Member who is facilitating an event/PD session and travels to another site can claim mileage from <u>school</u> to site to home
- The released team (i.e., President, Vice President, and Secretary-Treasurer) subtracts mileage from home from the PETL Office to and from other sites that they visit during the course of their workday
- Chairs and VP Liaisons should double-check that all mileage submitted is being claimed according to the above and is accurate as per GoogleMaps
- Event Attendance Twenty Percent
 - Committee Members "working" an event are excluded from the 20 percent cap on Committee Members attending events as long as they are exclusively working or facilitating the event and not participating in the event
 - If there are tickets/supplies remaining after registration closes, exceptions to the 20 percent can be made to allow additional committee members to attend
